Regarding the application process at age 18

It is important to know that individuals who plan to apply at 18 must apply in the first month AFTER they turn 18. Otherwise, parent income and assets are deemed to the child.

- SI 01320.550 Deeming
Child attains age 18.
Deeming stops effective the month following the month an individual attains age 18.
